

# Trillium

TRILLIUM is a 501 (c) 3, non-profit behavioral health provider network comprised of six Indiana Community Mental Health Centers—all of whom are Indiana Certified Managed Care Providers (MCP) for the State of Indiana Division of Mental Health and Addiction and also certified as Indiana Community Mental Health Centers. Incorporated in 1999, TRILLIUM offers access to clinical behavioral health providers in 33 counties –a third of the state of Indiana. The TRILLIUM Network of providers each maintain CARF and/or Joint Commission accreditation under the Behavioral Health accreditation standards.



The purpose of TRILLIUM is to provide coordinated mental health and substance abuse services to residents in the region served by the Trillium partners. This may include coordination of mental health services, quality assurance activities, training, and/or other information-sharing between Trillium members.
