# Happy Summer to our members, affiliate members, partners, legislatures, and key stakeholders-

What a summer it has been! The Council started its summer in DC advocating to the federal legislature for Indiana to be one of the states selected to be in the **SAMHSA/CMS CCBHC Demonstration**. We learned then that Representative Bucshon was co-sponsoring the Mental Health Access Improvement Act that would allow CCBHC to be a Medicare provider type.



We also were able to get support from all the Indiana delegation to sign a letter of support for the demonstration - something that, as some of them shared, has not happened since the Farm Bill. I am grateful for the members who joined me on this DC visit and for our federal lobbyist team for making it such a success.

From there, the Council was able to be a part of members crisis stabilization services and receiving openings at **4C Health** and **Adult and Child**. Thanks to the state and many other key stakeholders, those we serve now have a place to go when in crisis.

As our state advocacy continued to take place, we learned that Indiana was awarded the **State Demonstration for CCBHC**. The Council is grateful to the leadership at DMHA and our 8-member pilot sites for the work that they put in to make the application a success. We are also grateful for all the state and federal letters of support that were sent to SAMSHA on behalf of our membership. It was a true collaborative effort to get us to this award and it will continue to be as we enhance our system to CCBHC!

The timing of that notice could not have been better since we were back in DC that week for **National Council Hill Day**. We were able to thank our federal legislators directly. We again had amazing advocates from our CMHCS that helped us advocate for many federal policies including CCBHC and workforce. *See photos on page 7.* 

Once back from Hill Day, it was time for the **Council's annual board retreat**, (photo on page 6) where the board updated our *why and how* statements and strategic initiatives. One of the new statements that the board added is –

The Indiana Council is the hub that ensures the safety net is strong and 92 counties have access to quality, community-based behavioral health services. We are focused and dedicated to sharing information and resources to create a level playing field for our member CMHCs to succeed.

We are the united brand resulting from a merger of two well-known organizations in our area, Family Service Society, Inc. and Grant Blackford Mental Health, Inc. Our goal for the merger was to retain talent in our rural area, provide a full continuum of care from cradle to grave, and aggressively pursue CCBHC designation as a pathway to better care for our communities.

Our primary service area is Grant and Blackford counties as well as the surrounding contiguous counties that are part of our mobile crisis service area. Our organization is **220 employees strong** and growing. We pride ourselves for having grit and maintaining agility in times of change.

**Transforming toward CCBHC** has been a part of our vision since prior to the merger being finalized in April 2022 and we are energized to be part of the pilot moving the entire state toward CCBHC implementation and success.

Big wins the last 12 months include the full implementation of **Same Day Care** that reduced client wait times from 6 weeks or more to 2.5 hours. We offer Same Day Care at all outpatient locations. In addition, our crisis services team has been 24/7 since August of 2023.

Our mobile crisis team was certified in October of 2023 as the 2nd certified team in the state. To date we have responded to over 500 mobile crisis calls and intervened in 22 suicides where the individual had both means and intent when our team arrived. That's real impact. We're saving lives.

Radiant's future looks bright! We wake up each morning with one intention—save lives by making mental health access easy. As we look forward, we are reimagining the client experience, deconstructing all of our systems and process with an eye toward simplification—not just for our clients, but for our teams as well. Taking care of our own is the best path to excellence in care for others. We continue to look at innovative ways to diversify revenue and build long term sustainability into the organization. We're taking the long view as we set our sights on a future that creates a brighter kind of better for every life we touch.

### DMHA QA/QI Quality Assurance Training

# Cost-sharing for HIP program to remain paused at this time

FSSA is working with its attorneys and consulting with its federal partners at Centers for Medicare and Medicaid Services and will explore all legal remedies regarding the June 27 ruling regarding the lawsuit against the Healthy Indiana Plan.

At this time, cost-sharing for the HIP program, including POWER account contributions and co-pays, will remain paused. MEDWorks and CHIP co-pays will resume effective July 1 as planned.

Indiana strongly disagrees with the ruling and believes the actions have unintended consequences. The implications of the decision handed down are far-reaching. FSSA is still evaluating the impact for the state and the 762,000 Hoosiers who rely on healthcare coverage through the Healthy Indiana Plan. HIP was designed to provide healthcare coverage to non-disabled adults ages 19-64, empowering them to become engaged and active consumers of their health care.

At this time, individuals on the Healthy Indiana Plan remain covered, but there is uncertainty as to what services are included in that coverage.

While the lawsuit took aim at HIP's POWER account contributions or premium-like payments, the June 27 decision revoked the entire 10-year waiver approval granted to Indiana in 2020 to operate HIP – creating uncertainty regarding which services are covered for HIP members and removing authority for certain administrative aspects of the program's operation. The ruling also has implications that conflict with state law.

### Resources available to help individuals transitioning to Indiana PathWays for Aging or Health and Wellness Waiver

On July 1, individuals age 59 and younger who had been receiving services through the Aged and Disabled waiver will begin receiving services through the Health and Wellness waiver.

FSSA is also launching Indiana PathWays for Aging, a Medicaid managed care program for individuals aged 60 and over. Some individuals on the PathWays program will qualify for additional services based on their needs and will be eligible for the **PathWays home and community-based services waiver.** 

Those individuals were previously served by the Aged and Disabled waiver as well.



FSSA is committed to helping individuals and families navigate the transition. Multiple resources, including **a guide for who to contact** if you are in need of assistance, are available to help members navigate any challenges faced with the transition.

### **REQUEST FOR FUNDING -**

### **Mobile Integrated Response System**

The Indiana Family and Social Services Administration Division of Mental Health and Addiction is releasing a request for funding for the Mobile

Integrated Response System program using federal funding provided by the Substance Abuse and Mental Health Services Administration, State Opioid Response grant. The program uses a combination of the Trauma-Informed – Recovery Oriented System of Care and communitybased mobile response teams to close critical system gaps in local regions across Indiana.

The MIRS program was designed to serve people with opioid use disorder starting in 2019, and in 2020 stimulant use disorders were added. MIRS teams must include at least one peer recovery coach or specialist per county on their team, but can also include clinical staff, case managers, social workers, law enforcement officers, and program managers. All MIRS teams must have a referral system in place to connect to individuals who may need program services. The core function of a MIRS team is to provide a warm handoff for the individual to the next appropriate intervention and step towards recovery. The mission of a MIRS team is to meet people where they are at to help connect them to the resources they need.

### Biden-Harris Administration Announces \$27.5 Million in Funding Opportunities Enhancing Women's Behavioral Health | SAMHSA

## Community-Based Maternal behavioral health services program – \$15 million

o This program improves access to timely, culturallyrelevant, evidence-based maternal mental health and substance use treatment. Specifically, the program strengthens community referral pathways and provides seamless transitions in care for pregnant women who are at risk for or currently have a behavioral health condition in the perinatal and postpartum periods.

## Women's behavioral health technical assistance center - \$12.5 million

 This program will enhance the capacity of women's behavioral health providers, general health care providers, and others involved in the holistic care of women to address the diverse needs of women with or at risk for mental health and substance use conditions. The program is expected to identify and improve the implementation of evidence-based practices in women's behavioral health across the life span.

### • Changing the Course on Suicide: The Launch of a New National Strategy for Suicide Prevention

In the United States, someone dies by suicide every 11 minutes; the rates of suicidal behaviors have risen over the past decade; and disparities in suicide rate among certain populations are growing. There also is concern about suicide trends amid the ongoing mental health and overdose crises and on the heels of the COVID-19 pandemic, in which many people experienced loss, social isolation, behavioral health problems, and inequities in health care resources, education, housing and other suicide risk factors. **Read more about our nation's plan to prevent suicide** and turning strategy into action.

### • Biden-Harris Administration Announces \$31.4 Million in Funding Opportunities for Priority Behavioral Health Needs

On June 14, the U.S. Department of Health and Human Services, through the Substance Abuse and Mental Health Services Administration (SAMHSA), **announced notices of funding opportunities aimed at improving behavioral health** for

racial and ethnic minorities, and other underserved populations, providing training and technical assistance to programs serving these populations, and integrating primary and behavioral health care. The funding totals \$31.4 million and supports the Biden-Harris Administration's efforts to address the mental health and overdose crises, two key pillars of the President's Unity Agenda. The funding opportunities include investments in a range of behavioral health efforts.

### Notice of Funding Opportunity -Community-Based Maternal Behavioral Health Services Program

#### Application Due Date: Monday, August 26, 2024

The purpose of this program is to improve access to evidence-based, timely, and culturally relevant maternal mental health and substance use (behavioral health) intervention and treatment by strengthening community referral pathways. Recipients will be expected to collaborate with pregnancy and postpartum healthcare organizations, refer individuals in need of behavioral health care to the appropriate entities, and provide short-term mental health and substance use services to individuals who cannot access care.

### 988's Two-Year Anniversary:

We celebrate with the state the success 988 has had with 94% of 988 calls placed in Indiana were answered in state, the fourth-highest rate in the nation and better than the national average of 88%.

The National Council for Mental Wellbeing President and CEO Chuck Ingoglia stated "In the two years since 988 became available in 2022, untold numbers of lives have already been saved. More than 10 million people have contacted the 988 Lifeline through calls, chats and texts since the transition to the new service.

"Still, we have just barely scratched the surface of its promise and potential. Building the ideal crisis care system doesn't happen overnight – just as the 911 system has become ubiquitous in the United States over decades of improvements and efforts to expand capacity, 988 will become more effective and increasingly impactful as it matures.

"National Council for Mental Wellbeing members, including Certified Community Behavioral Health Clinics (CCBHCs), provide these lifesaving crisis services every day. The CCBHC model offers powerful advantages for the funding, sustainability, implementation, coordination and enhancement of crisis response services in communities across the nation and serve as an important component of both local and national crisis response networks.

"Fully establishing the CCBHC model as a permanent part of our health care system through the Ensuring Excellence in Mental Health Act and improving the

efficiency of 988 through legislation like the Local 9-8-8 Response Act represent our best hope to quickly expand access to quality, reliable mental health and substance use care in communities across the country.

### CMS Issues CY 2025 Physician Fee Schedule Proposed Rule

On Wednesday, the Centers for Medicare & Medicaid Services (CMS) issued a proposed rule that solicits public comments on proposed policy changes for Medicare payments under the Physician Fee Schedule (PFS), and other Medicare Part B issues, effective on or after January 1, 2025. # Behavioral Health Parity Rule submitted to OMB

On Monday, July 1, the U.S Department of Labor (DOL) submitted a rule to the White House Office of Management and Budget (OMB) that seeks to address disparities in treatment for mental health and substance use disorder challenges. In conjunction with HHS and the Department of Treasury, DOL first issued the proposed rule, **Requirements Related to the Mental Health Parity and Addiction Equity Act** (MHPAEA), in August 2023.

### Marketing Committee

The Marketing committee met on June 20th. Zoe Frantz shared council updates with the committee.

The committee discussed the need for each CMHC to submit 2-3 testimonials with the focus of CCBHC, Crisis Care, Group Home, and Workforce development.

The deadline to submit these to LeeAnn Jordan is August 15, 2024.

Finally, the committee shared some success stories and activities around workforce development and the use of AI in their departments.

### Quality Improvement Committee

- Allowing audit access when audit is taking place to assist surveyor in "finding" items that they aren't able to locate in file.
- c. CCBHC transformation what are current measures, what will be state requirements, how can we work together as a group to make that process smooth

The Adult Service Committee remains committed to maintaining connections with fellow CMHC leadership to problem solve specific issues, provide feedback where members have more experience in a certain area, and share new programming individual centers have initiated.

As I've shared before, some of our members have been active in sub-groups of the Adult Services Committee including the Residential Workgroup and ACT Workgroup. At our recent meeting, one center shared new interest in exploring AMHH in response to MRO service pack issues due to PA's being denied. Another center encouraged exploration of IOT for both mental health and substance use treatment.

#### Kelli Waggoner

### Northeastern Center's Community Health & Outreach Center:

### Providing Essential Services To Locals In Need.

The Northeastern Center's Community Health & Outreach Center which houses the NEC Cares, NEC Connect, and Emergency Solutions, & Targeted Case Management programs has been providing essential mental health-based services to local individuals in our communities for the



**last few months.** NEC Cares provides short-term, observation and crisis stabilization services in a home-like, non-hospital setting. NEC Connect provides free transportation to any adult in the criminal justice system. Emergency Solutions is a 24/7 emergency mental health hotline that is available to anyone experiencing an emergency mental health crisis. The Targeted Case Management Program work with clients and their outpatient care team to provide intensive outpatient treatment to people experiencing serious mental illness and substance use disorder.

The Community Health & Outreach Center has been open since August of 2023, with the NEC Connect and Emergency Solutions programs residing there since its opening, NEC Cares opened in December 2023 as a pilot program and began full 24/7 operation in the first quarter of 2024. NEC Cares provides walk-in, referral, and drop-off options for those entering the program. Individuals can remain at the NEC Cares program for up to 23 hours. During that time NEC Cares operates under a 'no-wrong door' approach and individuals will not be turned away if NEC Cares is unable to directly assist them and they will work on finding the individual the help they need elsewhere and getting them connected with that program or service.



#### **COMMUNITY NEWS**

In the 10 months since the Community Health & Outreach Center's inception, the programs it provides have been able to make an irreplaceable and positive impact on law enforcement, community organizations and individuals in need; providing stabilization for those in crisis, filling transportation gaps and providing emergency mental health assistance. Organizations



and law enforcement within the local communities have had a great deal of positive feedback to offer regarding the services the Community Health & Outreach Center provides.
