Crisis Services and Group Homes Analysis

For Discussion Purposes Only

- As part of the anticipated transformation to the Certified Community Behavioral Health Clinic (CCBHC) model, the CMHCs in the State of Indiana have been providing related Crisis Services.
- > Certain of the CMHCs also provide behavioral healthcare in Group Homes.
- This study provides an analysis of the provision of care in Crisis Services settings compared to the cost of Inpatient Hospitalization and/or the cost of Jails.
- This study also provides an analysis of the provision of care in Group Homes settings compared to the cost of State Psychiatric Hospitalization.



Crisis Services/Group Homes Study – Information Sources

- The information herein related to the CMHCs was derived from a survey across the state.
- The survey information was requested for the period of January 1, 2024 through June 30, 2024.
- > The results are annualized to get an estimated annual impact.
- The information related to inpatient hospitalization was computed using 25 hospitals using an average length of stay of 5 days (cost per day of \$1,070.56)
- The information related to jail costs was computed from an analysis 9 counties total budget for jail costs divided by the associated jail population.
- The information related to cost per client (total costs divided by total clients) in a state psychiatric hospital was computed utilizing 6 state psychiatric hospitals in the state.
